

LETTER OF AGREEMENT BETWEEN  
CHARLOTTE ASSOCIATION OF SCHOOL ADMINISTRATORS  
and  
CHARLOTTE PUBLIC SCHOOLS BOARD OF EDUCATION

**RE: ADMINISTRATIVE COMPENSATION**

1. This Letter of Agreement is entered into between the Charlotte Public Schools Board of Education (the "District") and the Charlotte Association of School Administrators (the "Association").
2. For the 2023 Summer School program, the program principal shall be compensated at a rate of \$8,500 (Eight Thousand Five Hundred Dollars), less normal withholdings, for the District established summer school session. The payment for Summer School will be made on or before July 15, 2023.
3. Year-round administrators are exempt from this summer school position.
4. Principal will be expected to fulfill the entire obligation of this assigned Summer School session. Absences will result in a per diem loss of pay at a rate of \$500 (Five Hundred Dollars) per day. Principal will not have access to paid or unpaid leave under the existing collective bargaining agreement. Principal will abide by all District policies and procedures.
5. Principal is expected to supervise in-person at the building they are assigned according to the established Summer School schedule. Principal shall arrive at least 30 minutes prior to the student instruction start time and stay at least 30 minutes after the student instruction end time, or until all students are picked up.
6. Principal will be provided with a 30-minute duty free lunch. There will be no other paid release time during the students' scheduled summer school session.
7. Nothing in this Letter of Agreement shall constitute a precedent, practice or established working condition for prior circumstances involving the application or interpretation of the current Agreement between the District and the Association or any successor collective bargaining agreement between them.
8. This Letter of Agreement expires on June 30, 2023.
