Dear Parents and Community Members:

We are pleased to present you with the Annual Education Report (AER) which provides key information on the 2022-203 educational progress for the Washington Elementary. The AER addresses the complex reporting information required by federal and state laws. The school's report contains information about student assessment, accountability, and teacher quality. For the 2022-23 school year, schools were identified using definitions and labels as required in the Every Student Succeeds Act (ESSA). A Targeted Support and Improvement (TSI) school is one that has at least one underperforming student subgroup. An Additional Targeted Support (ATS) school is one that has three or more underperforming student subgroups. A Comprehensive Support and Improvement (CSI) school is one whose performance is in the lowest 5% of all schools in the state or has a graduation rate at or below 67%. Some schools are not identified with any of these labels. In these cases, no label is given.

The state has identified some schools with the Status of Targeted Support and Improvement, Additional Targeted Support, Comprehensive Support and Improvement. Our school has not been given one of these labels.

The school is taking the following steps to accelerate student achievement:

- Continue to analyze demographic, perception, student achievement, program and process data to identify areas of need.
- Differentiate instruction for all students.
- Provide additional instructional support for students at-risk of not meeting challenging State Standards through small group or one-to--one instruction.
- Provide additional instructional support for students who are demonstrating abilities above grade level State Standards through small group or one-to-one instruction.

- Provide additional instructional support for students at-risk of not meeting challenging State standards through providing high quality- on-going professional development for teachers and support staff.
- Providing additional resources, supports and instruction around Social Emotional and Character/Moral focus education to support continued growth in positive student outcomes.

The current challenges of Washington Elementary in the 2022--2023 School year have been the following:

- Differentiated Instruction to support growth for all students
- School attendance/truancy for students who remain attendance concerns
- Addressing possible impact of COVID, (in person and virtual learning) and quarantining of classrooms on learning ready for grade level content

# 5. THE AGGREGATE STUDENT ACHIEVEMENT RESULTS FOR ANY LOCAL COMPETENCY TESTS OR NATIONALLY NORMED ACHIEVEMENT TESTS

Washington Elementary evaluates the academic progress of its students by administering common assessments, weekly and unit assessment, a District assessment three times a year by implementing NWEA assessments. Third grade students participated in the state wide MSTEP assessment. Data indicates that there is a positive trend in growth among all student groups.

• Washington MSTEP students Scoring Advanced or Proficient in Math was 38% in comparison to the State Average of 35% in 2020-2021

- Washington MSTEP students Scoring Advanced or Proficient in ELA was 33% in comparison to the State Average of 48% in 2020-2021
- 2020-2021 Scores for MSTEP were greatly impacted by pandemic
- Washington MSTEP students Scoring Advanced or Proficient in ELA was36% in comparison to the State Average of 45% 2021-2022
- Washington MSTEP students Scoring Advanced or Proficient in Math was37% in comparison to the State Average of 34% in 2021-2022

- 6. IDENTIFY THE NUMBER AND PERCENT OF STUDENTS REPRESENTED BY PARENTS AT PARENT-TEACHER CONFERENCES

Washington Elementary believes that a strong parent-school connection is vital to high achievement of students. #### PARENT-TEACHER CONFERENCE AVERAGES

During the 2020-2021 school year, 92% of Washington Elementary School students' parents/guardians attended fall conferences and 85% attended spring conferences. During the 2021-2022 school year, 89% of Washington Elementary School Students' parents/guardians attended fall conferences and we currently have not held our 2021-2022 spring conferences. For the 2021-2022 conferences were held through Google Meets, emails, in person and phone calls.
